

THIRD AMENDMENT TO AGREEMENT

This THIRD AMENDMENT TO AGREEMENT (Amendment) made and entered into as of this ____ day of _____, 2024 (Effective Date), amends the Agreement entered into by and between the City of Fresno, a California municipal corporation (City), and Flock Group Inc., of Atlanta, Georgia (Contractor)

RECITALS

WHEREAS, the City of Fresno Police Department and Contractor entered into a Master Service Agreement (Agreement) dated February 22, 2024, for compensation not to exceed \$1,498,690.41; and

WHEREAS, on October 30th, 2024, the City of Fresno Police Department entered into a First Amendment to modify the Agreement with the addition of cameras and services for an increased monetary amount of \$33,250.00, erroneously written as \$33,500.00 in the First Amendment, for an updated total compensation not to exceed \$1,531,940.41; and

WHEREAS, on October 30th, 2024, the City of Fresno Police Department entered into a Second Amendment to modify the Agreement for a product exchange to which there were no additional costs or change to the total contract value; and

WHEREAS, the City and Contractor now desire to amend the Agreement to include the Department of Public Utilities for subscription services of cameras and software, for compensation not to exceed \$136,500.00, and a total Agreement compensation not to exceed \$1,668,440.41; and

WHEREAS, with entry into this Agreement, the Contractor agrees it has no claim, demand, or dispute against the City.

AGREEMENT

NOW, THEREFORE, the parties agree that the Agreement be amended as follows:

1. The recitals of this Amendment are incorporated and made a part of the Agreement.
2. Contractor shall provide the services as described in **Attachment A**, attached hereto and incorporated herein by reference.
3. Compensation. The parties acknowledge the total compensation provided in the Agreement is hereby increased to One Million Six Hundred and Sixty Eight Thousand Four Hundred and Forty Dollars and Forty-One cents (\$1,668,440.41).
4. Except as expressly modified by this Amendment, the Agreement remains in full force and effect. In the event of any conflict between the Agreement and this Amendment, this Amendment shall control.
